Participation rules	<ol style="list-style-type: none"> <li>1. The entry limit for the competition is 40 people</li> <li>2. A participant can only compete in one competition.</li> <li>3. A category is created when min. 4 participants.</li> <li>4. In the event of fewer entries in a category, the competitor will automatically be moved to another category.</li> <li>5. If it is not possible to move to another category and at least 3 players apply, half of the ranking points due shall be credited. If it is not possible to move to another category and at least 3 players have entered, half of the ranking points due will be credited.</li> <li>6. Participants of the competition are obliged to present in the competition office, signed statements required by the Organiser (forms can be downloaded at <a href="http://www.ckis.pl">www.ckis.pl</a> or in the competition office)</li> </ol>
